EXPLANATORY NOTE

WHEREAS, Section of the Local Government Code of 1991 the so called "general welfare clause" which empowers local government units to enact and implement measures for the general well-being of their inhabitants;

WHEREAS, Republic Act 9994 – Expanded Senior Citizen Act provides a monthly pension of Five Hundred Pesos (Php500.00) to indigent Senior Citizens augment their daily subsistence and other medical needs;

NOW THEREFORE, on motion of Councilor Marivic S. Robeniol, duly seconded by Councilors Athena Ira G. Chua, Johnny Mar A. Carig, Jesus V. Pico and Melchor J. Cardinez, Sr., it was,

RESOLVED, as it is hereby resolved, to approve the following Ordinance, to wit:

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF FIVE HUNDRED PESOS (PHP500.00) TO SENIOR CITIZEN RESIDENTS OF THE MUNICIPALITY OF ASINGAN, PANGASINAN

Be it enacted by the Sangguniang Bayan of Asingan, Pangasinan, in session assembled that:

Section 1. Title. This ordinance shall be known as "An ordinance granting financial assistance in the amount of Five Hundred Pesos (Php500.00) Senior Citizen residents of the Municipality of Asingan".

Section 11. Definition of Terms. For purpose of this ordinance, these terms are defined as follows:

- a. Senior Citizen – refers to any resident citizen of the Municipality of Asingan at least sixty (60) years old;
- b. Debilitating Diseases – refers to any elderly from those who attack the muscles in our body and affect our physical abilities to those that affect our brain function and impair our thought processes such as rheumatoid arthritis, schizophrenia, poliomyelitis, muscular dystrophy, cerebral palsy, chronic obstructive.
- c. Resident – a person who lives somewhere permanently for at least six (6) months residency.

Section 111. Qualifications of Senior Citizen for the Five Hundred Pesos (Php500.00) financial assistance from the Municipality of Asingan.

- a. Must have a Senior Citizen identification card.
- b. Must be a resident of Asingan with the certification from the Punong Barangay.
- c. Priority recipients must be aged eighty (80) years old and above, and
- d. Senior Citizens with debilitating diseases such as rheumatoid arthritis, schizophrenia, poliomyelitis, muscular dystrophy, cerebral palsy, chronic obstructive.

Section IV. Mechanics of the Implementation of Financial Assistance.

1. The granting of financial assistance will start on January 2020 initially for five (5) qualified Senior Citizen from the twenty one (21) barangays of Asingan. A Screening Committee to be created by the Municipal Mayor will be responsible in the selection of the five (5) recipients in every barangay.
2. In every month thereafter, additional five (5) qualified Senior Citizens from the twenty one (21) barangays shall be added.

Section V. Schedule of the granting of Financial Assistance.

- a. The financial assistance of Five Hundred Pesos (Php500.00) from the Municipality of Asingan on the 3rd week of every month.

Section VI. Source of Funding – The funds will come from the general fund of the Municipality of Asingan.






