**EXPLANATORY NOTE**

WHEREAS, Section 21 of the Local Government Code of 1991 provides that a Local Government Unit (LGU) pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park or square falling within its jurisdiction: Provided, however, that in case of permanent closure, such ordinance must be approved by at least two thirds (2/3) of all members of the Sanggunian and when necessary, an adequate substitute for the public facility that is subject to closure is provided;

WHEREAS, the closure of L. Millan Street is for the safety and security of the Municipal employees, teaching staff and pupils of the Narciso R. Ramos Elementary School, SPED Center, the Philippine National Police (PNP) and all other constituents transacting in the Municipal Hall, Philippine National Police (PNP) and National Offices within the area;

RESOLVED, as it is hereby resolved, to approve the following Ordinance, to wit:

**ORDINANCE NO. 16  
SERIES 2021**

**AN ORDINANCE PERMANENTLY CLOSING TO ANY VEHICULAR TRAFFIC BOTH LANES  
OF L. MILLAN STREET, ASINGAN, PANGASINAN**

Be it enacted by the Sangguniang Bayan of Asingan, Pangasinan, in session assembled that:

Section 1. Title. This ordinance shall be known as "An Ordinance permanently closing to any vehicular traffic both lanes of L. Millan Street, Asingan, Pangasinan".

Section 2. Purpose. Permanent Closure to any Vehicular Traffic of both lanes of Millan Street, Asingan, Pangasinan.

Section 3. Separability Clause. If any provision or part of this Ordinance shall be declared unconstitutional or invalid, the same shall not affect the constitutionality or validity of the other provisions or part hereof.

Section 4. Repealing Clause. If any provision or part of any existing ordinance is not consistent with this Ordinance, the same is hereby repealed or modified accordingly.

Section 5. Effectivity. This Ordinance shall take effect upon approval and compliance with the mandatory posting and publication requirement, prescribed under R.A. 7160, otherwise known as the Local Government Code of 1991.
